Access will be granted in accordance with the Privacy Act 1988 for a reasonable fee; if any of your information is inaccurate, you may request that it is corrected.

When you provide Westpac with your valid Qantas Frequent Flyer membership number, you agree:

- a) to be bound by the BusinessChoice Rewards Card Rewards Terms and Conditions;
- b) that the BusinessChoice Rewards Cards Rewards Terms and Conditions apply to any Qantas Frequent Flyer points you earn using your BusinessChoice Rewards card or card account, and, once transferred to the Qantas Frequent Flyer program, the Qantas Frequent Flyer program terms and conditions apply to those points;
