### Westpac confirms issuance of Westpac SPS II

Further to our announcement on Monday 30 March 2009, Westpac Banking Corporation confirms that 9,083,278 Westpac SPS II at A\$100 each have been issued and transferred to successful Westpac SPS II applicants.

The information set out below is for the benefit of Westpac SPS II holders.

**Conditional and deferred settlement trading** – Westpac has notified ASX that the conditions of the conditional market for trading of Westpac SPS II have been satisfied. The Westpac SPS II will trade on an unconditional and deferred settlement basis from later today.

It is expected that normal trading on ASX will commence on Wednesday 8 April 2009.

**First Distribution** – The record date for the first Distribution Period is 23 June 2009 and the first Distribution is expected to be paid on 30 June 2009. The estimated Distribution Rate for the first Distribution has been determined as follows:

90 day Bank Bill Rate on 31 March 2009	3.1383% p.a.
Plus Margin	3.80% p.a.
	6.9383% p.a.
Multiplied by (1 – Tax Rate)	0.70
Estimated Distribution Rate	4.8568% p.a.

Distributions are expected to be fully franked and accordingly holders are expected to receive cash distributions and franking credits. The potential value of franking credits does not accrue at the same time as holders receive cash distributions and a holder's ability to use franking credits will depend upon the holder's individual tax position.

**Maximum Conversion Number** – For the purposes of the conversion calculations, as outlined in the Westpac SPS II Prospectus, the Maximum Conversion Number is 11.4220 based on the Issue Date VWAP of \$17.51.
