2. Administrator(s) registration

Administrators will have access to all Accounts and be able to:

- manage Online Banking access and permissions via the Administration settings in Online Banking;
- perform all tasks they are authorised to do in accordance with the Online Banking Terms and Conditions, including, but not limited to create and set approval requirements (where applicable) for Business Servicing Requests and open everyday, savings or Term Deposit accounts (where these are able to be opened in a Business Network through Online Banking) on behalf of the Network Owner in accordance with the Online Banking terms and conditions. Separately, Administrators of Business Networks may grant any User the ability to create Business Servicing Requests, to manage PayTo® Payment Agreements on eligible Accounts and to open such accounts on behalf of the Network Owner. [Note: if the account authority specifies a greater number of approvers is required, then that number of approvers will apply (rather than the number as set by the Administrator)].
- nominate themselves and/or Users within the Business Network who may give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients on behalf of the Organisation and to revoke any or all such nominations. (Note: ALL of the Organisation's Open Banking Accounts will be available to any Administrator or User to select some or all for data sharing. Open Banking Accounts include accounts that are open, closed, not visible in Online Banking and accounts that the Administrator or User may not have access to in Online Banking).

3. Authorisation and acknowledgement – Business Network Owner

Executive Officer/s of the Network Owner must read and sign this section.

Administrator Authorisation.

I/We nominate and authorise the individual(s) nominated as an Administrator, to be an Administrator on my behalf as the Network Owner in respect of all User/s and all accounts accessible through Online Banking and/or Group Telephone Banking. I/We authorise Administrator/s to manage the Network and complete administration tasks as described in the Online Banking Terms and Conditions.

Additional Administrator authorisation.

I/We also agree that:

- Westpac may accept instructions through Online Banking from any Administrator(s) in the Network in relation to Business Servicing Requests, including adding additional cardholders, reissuing existing Business Debit Mastercards, opening everyday, savings or Term Deposit accounts or Merchant Facilities, or enabling PayTo on eligible Accounts for and on behalf of the Network Owner;
- the Administrators are authorised to grant any User the ability to create a request to open everyday, savings and Term Deposit accounts, to manage PayTo Payment Agreements on eligible Accounts, and in relation to Business Servicing Requests for a User with Approver access to Approve;
- the Administrators are authorised to nominate themselves and/or Users within the Business Network who are able to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients on behalf of the Organisation and revoke any or all such nominations.

3. Authorisation and acknowledgement – Business Network Owner (continued)

I/We acknowledge and agree that:

- any Administrator, or any User who has been granted the ability to issue instructions in accordance with this authority, may receive disclosures relating to the account or Business Servicing Request or Merchant Facility, and can accept the terms and conditions of the Business Servicing Request or account, including interest rates and fees and charges, for and on behalf of the Network Owner. Such disclosures and terms and conditions may be communicated to an Administrator or User electronically, including through Online Banking;
- any Administrator may (where applicable) set the approval requirements for Business Servicing Requests for and on behalf of the Network Owner in accordance with the Online Banking terms and conditions. [Note: if the account authority specifies a greater number of approvers is required, then that number of approvers will apply (rather than the number as set by the Administrator)];
- any instruction given or acceptance provided by an Administrator or a User that is nominated to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients on behalf of the Organisation in accordance with this authority, does not need to be verified by Westpac, and is issued with the full authority of the Network Owner and will bind the Network Owner as if they had issued the instruction themselves;
- any account opened in accordance with this authority will be automatically added to the Business Network with a default of any one to operate. Withdrawals on an account will not be able to be effected through a Branch or other physical channel until such time as the Network Owner establishes an Account Operating Authority with Westpac for the specific account;
- this authority is in addition to any other authority that the Network Owner has provided to Westpac to open or operate accounts and that it does not alter or replace any such authority;
- subject to Westpac cancelling this authority (as permitted by this authority), this authority will continue in full force and effect until Westpac receives a written notice (in the form required by Westpac) from the Network Owner of its:
 - instructions to cancel Online Banking;
 - removal of the Administrators, and any Users granted any rights or permissions pursuant to this authority, for the Business Network;
 - removal of the ability of all Administrators to nominate themselves and/or Users within the Business Network to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients, on behalf of the Organisation and revoke any existing authorisations to share data on behalf of the Organisation.
- Westpac reserves the right to cancel this authority at any time and for any reason without notice;
- any account opened in accordance with this authority will be opened in the name of the Network Owner and in no other capacity, notwithstanding any existing relationship the Network Owner may have with Westpac.

Westpac may accept instructions through Online Banking from an Administrator to nominate themselves or any Users to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients and to revoke any or all such nominations.

- An Administrator or User nominated by an Administrator to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients may initiate data sharing via a request made by an Accredited Data Recipient.
- The Organisation's Open Banking Account data will be shared in accordance with the Australian Government Consumer Data Right legislation, rules and requirements.

Once a PayTo Payment Agreement is authorised, you acknowledge that personal information such as:

- your name and Account details;
- details of your PayTo Payment Agreement(s) and Migrated DDR Mandate; and/or
- other personal information, including sensitive personal information such as health information, may be viewed and managed by authorised third parties, assigned Users in a Network with On-share Access, joint account holders and the nominated Users in your Network(s) with assigned access to the Account.

3. Authorisation and acknowledgement – Business Network Owner (continued)

I/We indemnify Westpac against any claims, losses, damages or costs suffered or incurred by Westpac as a result of Westpac acting in accordance with this authority, including but not limited to any claims for breaches of privacy or confidentiality, or fraud caused, or contributed to, by an Administrator or User nominated by an Administrator to give, amend and manage authorisations to share the Organisation's Open Banking Account data with Accredited Data Recipients. This indemnity survives cancellation of this authority.

I/We represent and warrant all things necessary, including obtaining any approvals or corporate authorisations, to enter into this authority and the transactions it contemplates, have been done.

I/We undertake to advise you as soon as practicable should the authorisation/nomination of any Administrator or User be revoked or the individual cease to be an employee of the Organisation.
