## Westpac Self-Funding Instalments

### Notice to investors

*The purpose of this notice is to provide updated information to investors in Westpac Self-Funding Instalments ('Westpac SFIs') issued by Westpac Banking Corporation ABN 33 007 457 141 AFSL 233714 ('Westpac') under the Product Disclosure Statement dated 1 July 2013 as supplemented by the Supplementary Product Disclosure Statement dated 29 April 2016 ('PDS').*

*In addition, effective from the date of this notice the Terms of Issue have been varied. Material variations are reflected in the 'Changes to PDS' below. These variations apply to existing and future Holders.*

*Capitalised terms in this notice have the meaning given to them in the PDS unless the context requires otherwise.*

#### Changes to PDS

Westpac has updated the PDS. Effective from the date of this notice, the PDS will be updated as follows. These updates apply to existing and future Holders. The changes are:

##### **Section 4.2 The Loan**

*The following is added after the last paragraph under section 4.2(b) 'Loan Amount' on page 13 of the PDS:*

For a Westpac SFI, Westpac will not exercise the discretion to treat money as unclaimed money referred to in Section 10.22.

##### **Section 7.1 Significant legal provisions of the Trust Deed**

*The first paragraph under section (b) 'Limited liability and limited obligation of Security Trustee' on page 45 of the PDS is replaced with the following:*

The liability of the Security Trustee for losses or liabilities arising under or in connection with the Trust Deed is limited to the extent to which the Security Trustee is actually indemnified against those losses or liabilities out of the property of the Separate Trusts, provided that the loss was not caused by the Security Trustee's own dishonesty (or that of its officers or employees), a breach of trust or its own gross negligence.
